

## POLICIES OF THE SEAPORT INN

\*\*\*Please read in full before signing.\*\*\*

One night deposit is required to hold a reservation. The balance is due upon arrival. VISA, Master Card, Discover and American Express are accepted. We do not accept checks, only cash or credit/debit cards. Credit cards will be kept on file until rooms are inspected after check out. If you are paying cash for your room we will need a credit card on file at check in. Any damages to the rooms will result in a charge to your credit card in order to cover the cost of materials and labor. If a room is paid in cash and no credit card is available, an I.D. will be required in order to have a way to contact you if the rooms are destroyed or if something is stolen. At Check Out we will need the 2 complementary beach tags and room keys returned otherwise we will charge your credit card the price of replacement, and or locksmith fees.

No Guests will be allowed to rent a room if they are under the age of 21. If an under 21 year old books a room over the phone and comes to check in he/she will not be able to check in and NO REFUND WILL BE GIVEN.

NO FIREARMS ON THE PREMISES.

All rates subject to 12% NJ taxes.

Rates quoted on two (2) persons per room.

2 Night minimum on Friday and Saturday nights and 3 night minimum on Holidays.

Extra person in room is a \$10 fee per room per night.

Children 10 years and under are free.

Only 1 parking space per room is allowed and permit will be issued at check in.

Rooms are numbered based on level so 101 is 1st floor, 201 is 2<sup>nd</sup> floor and 301 is 3<sup>rd</sup> floor.

Check-In Time is 3:00 pm; check-out time is 11:00 am.

No visitors allowed without permission!

No bikes allowed in rooms.

Sorry, no pets. Kennels are nearby.

Sorry, no smoking in motel rooms.

Sorry – No elevators available.
